NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.

By entering into the Cotton Forward: 3D Fashion Design Challenge Competition 2024 (the "**Competition**"), entrants agree to be bound by the following Terms and Conditions:

- Entry Period. The Competition opens on January 3, 2024 ("Opening Date") and closes at 11:59
 pm Eastern Time on May 17, 2024 ("Closing Date"). No entries will be accepted before the
 Opening Date or after the Closing Date. Entries are limited to one (1) entry per person. Entries
 which are not in accordance with these Terms and Conditions are invalid. Entries comprising
 of anything which is obscene or vulgar, abusive, harmful, threatening, libelous, defamatory,
 invasive, profane, infringing, or otherwise unlawful shall be deemed to be invalid.
- 2. <u>Eligibility</u>. The Competition is open to United States residents who are over the age of 18 years and who are enrolled in or have graduated from college within the last two years (2023, 2022 and 2021 graduates). The following persons are not eligible to enter the Competition: (i) employees of Arts Thread and its respective franchises, subsidiaries, agents and advisors and their respective immediate family members (spouse, parents, siblings, children); (ii) employees of Cotton Incorporated and its respective franchises, subsidiaries, agents and advisors and their respective immediate family members (spouse, parents, siblings, children); (iii) employees of any other company, organization or person assisting or connected with the promotion and their respective immediate family members (spouse, parents, siblings, children).  - b. Use 3D software (CLO3D or Browzwear VStitcher) to design 1-3 complete, styled looks for any market or product category that uses, or could use, cotton.
 - c. Use cotton digital fabrics created by Cotton Incorporated, which are compatible with CLO and Browzwear. These digital fabric files are accessible for free from the CottonWorks™ website, a free resource for producing outstanding cotton products. New to CottonWorks? Follow these steps:

Step 1: Register for a free CottonWorks account

Step 2: Once you've registered and signed in, navigate to the FABRICAST Collection page

d. Entry Design Requirements:

- i. Entrants can choose any market or product category and may show any combination of markets and product categories in 1-3 complete, styled looks. For example, it's okay to do one men's look and two women's looks in your collection.
- ii. At least 80% of the design Entry must feature digital cotton fabrics from CottonWorks[™]. There are about 400 to choose from. Entrants may alter the color and/or print of the digital fabrics. Entrants may add prints to digital fabrics that don't have one.
- e. Entrant must have an Arts Thread account. New to Arts Thread? To enter, register (for free) to create an ARTS THREAD account and go to your email and click on the activation link sent to your email inbox. Then log into your account, upload your Entry and select "Cotton Forward: 3D Fashion Design Challenge Competition 2024 from the dropdown options available.
- f. The use of artificial intelligence in creating Entries is strictly prohibited.
- 4. Prizes. There will be Three (3) winners. The prizes shall consist of the following:
 - a. The First Prize winner shall receive five thousand US dollars \$5000.00.
 - b. The Second Prize winner shall receive three thousand five hundred US dollars \$3500.00
 - c. The Third Prize winner shall receive one thousand five hundred US dollars \$1500.00 (collectively, the "Prize/s").

No more than the stated number of prizes will be awarded. Any local, state or federal taxes are the responsibility of winners. Arts Thread will contact potential winners for verification and with further details of how to claim the Prize after the close of the Competition.

- 5. Judging Criteria, Judges and Winner Selection.
 - a. All Entries will be judged according to the following judging criteria:
 - i. 25% for Authenticity and Originality the design reflects a unique creative vision;
 - ii. 25% for Design Technique and Quality the designer has demonstrated technical skill in creating the digital garment(s);
 - iii. 25% for Overall Stylistic Concept the design is visually appealing and stands out as a work of fashion; and
 - 25% Material Use the designer has effectively used Fabricast digital fabric selections and has demonstrated an understanding of fabric benefits and performance.

- b. Winner Selection:
 - Each eligible Entry that complies with all of the Competition requirements will be submitted to the judging panel. Entries will be judged based on each of the 4 criteria listed above, and the top 3 Entries with the highest total score for all 4 criteria will be awarded prizes, with First Prize for the highest total score, Second Prize for the second highest total score and Third Prize for the third highest total score.
 - ii. In the event of a tie, the Entry with the higher score in the Material Use criteria will be ranked higher, and if that score is also a tie, the Entry with the higher score in the Overall Stylistic Concept criteria will be ranked higher.
 - All potential winners and potential winning Entries are subject to verification for compliance with these Terms and Conditions and may be disqualified for noncompliance.
- c. The Competition shall be judged by panel comprised of 5 representatives chosen by Arts Thread and Cotton Incorporated (the "Panel"). Each judge will be a practicing fashion designer, 3d industry practitioner or a fashion design educator, and each judge will have experience in using or teaching 3D fashion design. All decisions of the Panel are final.
- d. The potential winners shall be selected and notified by June 12, 2024. All potential winners are subject to verification. Potential winners will be notified via the email address by Arts Thread, provided with the Entry! All potential winners may be required to sign and return, where legal, an Affidavit of Eligibility, Liability/Publicity Release, Certification of Originality and/or rights transfer document within ten (10) days of prize notification. Additionally, potential winners may be required to submit releases from any and all third parties appearing in their respective Submissions. If potential winner cannot be reached within five (5) calendar days of first notification attempt, if any prize or prize notification is returned as undeliverable, if potential winner rejects his/her prize, if a potential winner does not timely complete and return required documents, or in the event of noncompliance with these Competition Terms and Conditions, such prize will be forfeited and Arts Thread may attempt to award the prize to the next potential winner with the next highest score.

- a. The parties waive all rights to trial in any action or proceeding instituted in connection with the Competition or these Terms and Conditions. Any controversy or claim arising out of or relating to these Terms and Conditions and/or the Competition shall be settled by binding arbitration in accordance with the commercial arbitration rules of the American Arbitration Association.
